## Job Summary

State Technical Officer, is at the forefront of ensuring the successful implementation of health projects at the state level. This role involves overseeing day-to-day activities, supporting program management, and engaging key stakeholders to drive the achievement of project goals.

#### **Roles & Responsibilities**

- Manage the day-to-day activities of the project at the state level
- Support the Program Manager and Program Officer
- Facilitate engagement of private Health facilities and other relevant stakeholders for the implementation of the grant;
- Organize & conduct regular data-driven health facility supervision to ensure quality TB, TB/HIV, and DR-TB surveillance and service delivery;
- Provide regular technical support and supervision to field personnel, including private health sector care providers, Linkage Coordinators, sample movers and other related staff providing services along the TB service delivery cascade;
- Ensure that project reports are developed and submitted timely to the Program Advisor and are of good quality.
- Conduct supportive supervisory visits to TB and HIV service providers in both facilities and the community as well as prepare and submit reports.
- Work closely with S/TBLS officers and support state TB/HIV Partners' forum to coordinate partner's support and implementation of key intervention areas.
- Assist in coordinating the program portfolio to ensure key performance indicators are met and project impact is in line with the strategy.
- Support facilities to ensure effective linkages for TB clinical cascade as well as integration with allied interventions including HIV/AIDS prevention, care and treatment;
- Work with relevant state staff to disseminate guidelines, tools and procedures that will support the achievement of quality service delivery;
- Contribute to the development of program strategies, subproject documents, work plans and budgets and ensure key performance indicators are met in line with the PPM strategy;
